## Parent Handbook

### Arrival and Pick-up

To ensure the safety of the students in our care, Homework Club Learning Center has implemented the following procedures: 1. Students will only be released to adults authorized in the application by the parent(s). Identification will be checked before any student is released until the staff becomes familiar with the individuals who pick up students. 2. Daily attendance will be taken, and parents will be notified by a text message to their primary caretakers' cell phone if their child is not at the Homework Club Learning Center location after 10 minutes of their scheduled time. 3. Each student must be signed out by an adult identified in the Identification and Emergency Information form. Students will not be released to anyone not listed on the emergency form. 4. It is critical that the information on the emergency form is current. If there are any changes, please let our staff know. 5. Homework Club Learning Center will not provide transportation for drop-off or pick-up unless agreed upon with parents/guardians. These measures are in place to ensure the safety and well-being of all students under our care.

### Absence Policy

Research consistently demonstrates that students who maintain consistent attendance and punctuality tend to achieve greater success in school. Parents play a crucial role in supporting their child's academic journey by ensuring they arrive on time and attend regularly. At Homework Club Learning Center, we hold all students to these standards to maximize their learning potential. It's imperative for students to commit to and respect their assigned schedules. Absences are only excused in cases of infectious diseases. We require a minimum of 2 weeks prior notification for all absences; failure to provide timely notice will result in non-reimbursement due to space limitations and enrollment restrictions. When we schedule a student, we dedicate our full attention and allocate a designated staff member to ensure their success. We are committed to providing each child with the support they need to thrive academically. Please note that termination of the contract requires a 10-day prior notice.

### Behavior

At Homework Club Learning Center, we strive to cultivate a safe and nurturing environment where students feel valued, respected, and happy. Our aim is to foster a sense of belonging and inclusivity, creating a space where students can become part of our family in an unbiased learning environment. We uphold a zero-tolerance policy towards any form of disrespect or bullying towards staff or fellow students. We expect all students to demonstrate kindness, politeness, and good manners in their words and actions. Our goal is to promote a cohesive and respectful community where students work harmoniously together. To maintain a focused learning atmosphere, we do not permit swearing, stealing, fighting, or any other form of disruptive behavior. Additionally, the use of cell phones during program hours is strictly prohibited. Cell phones must remain in students' backpacks throughout the duration of the program, and failure to comply will result in confiscation.

## **Discipline**

At Homework Club Learning Center, we maintain high expectations for student behavior, and it is essential that all students respect our rules and guidelines. In instances where a student does not adhere to these expectations, we will initiate a conference with their parents to address the concerns. Students who continue to disregard the rules may be removed from the group to work directly with the administrator. Our priority is to ensure that every student works in a happy and safe environment. In many cases, behavior issues can be resolved through private conversations with the student. We make every effort to address these concerns before involving parents. However, if the behavior issues persist despite our interventions, the child may be asked to be picked up from the program. It's important to note that any form of discipline or punishment that violates a child's personal rights is strictly prohibited, regardless of authorized representative consent or authorization. Students will never experience corporal punishment, denial of snack breaks, or denial of restroom use under any circumstances. Our ultimate goal is to create a positive and supportive learning environment where every student can thrive.

## **Admission Policy**

To enroll a student at Homework Club Learning Center, we require an interview with the parent/guardian and the child. Before attending, parents must complete an enrollment application packet. Upon request, we can schedule a quick observation of the program to provide insight into our activities and environment. We are committed to transparency and communication with our families. Therefore, we will provide a 30-day notice to the parent/guardian regarding any changes to the program, tuition, policies, or procedures. This ensures that parents are informed and have sufficient time to adjust to any updates.

## **Termination of Contract**

The contract with Homework Club Learning Center may be terminated by providing a 10-day written notice to the Director of the club. Additionally, Homework Club Learning Center reserves the right to terminate the contract for the following reasons: Student's continuous bad behavior, which includes but is not limited to: Interruption of class, Bullying, and Disrespect towards staff and other students. Prior to termination, the student will receive three warnings and parent conferences to address the behavior concerns. If the behavior persists despite interventions, Homework Club Learning Center may proceed with the termination of the contract.

## **Snacks and Breaks**

Students at Homework Club Learning Center will have scheduled 30-60 minute breaks during their sessions, which can be spent in the classroom or in the schoolyard. These breaks will be supervised by our staff to ensure the safety and well-being of all students. We encourage students to bring their own snacks and lunch to enjoy during these breaks. However, if needed, the Homework Club Learning Center may provide a small snack consisting of prepackaged non-perishable food items. Our priority is to ensure that students have the opportunity to refuel and stay energized during their time with us.

## **Medication Policy**

Homework Club Learning Center staff are not trained to administer ANY type of medication to students. Thus, medication will not be administered by our staff or stored on location.
